Greetings,

On April 1st, Hands & Voices entered into a three year cooperative agreement with the Health Resources and Services Administration (HRSA) to support the development of statewide newborn and infant hearing screening, evaluation, diagnosis, and intervention (**EHDI**) programs and systems. This will be accomplished by promoting the inclusion of families, parents and caregivers of deaf or hard of hearing infants/children identified through the Universal Newborn Hearing Screening Program as leaders in their statewide EHDI system.

This new cooperative agreement is called Family Leadership in Language and Learning (FL3) and its goal is to ensure that United States subsidized EHDI systems incorporate certain elements that support the families, parents and caregivers of deaf or hard of hearing infants/children identified through newborn hearing screening in optimizing language, literacy, and social-emotional development. The first quarter of the cooperative agreement has been busy with the start of a National Needs Assessment, providing technical assistance to EHDI systems stakeholders, and the convening of Advisory Boards. Work has also begun on developing website infrastructure to support the trainings and information that is being gathered.

As we continue into the next quarter, please reach out to us if you have questions or need assistance. We look forward to developing the resources that families need to optimize the language, literacy, and social-emotional development of their children who are deaf or hard of hearing.

FL3 Updates The First 3 Months

- The FL3 program is beginning the first 6 months of the project with a formal, national needs assessment that will be coordinated with the National Center for Hearing Assessment and Management (<u>NCHAM</u>) to gather information on family engagement within the EHDI systems. This information will be used to drive the content of the trainings, educational materials and resources that will be developed and distributed over the remaining period of the agreement.
- An advisory board of national experts on language, literacy, and social
 development with a broad range of experiences will convene to serve as
 advisors. The Advisory Board will summarize the latest evidence-based
 research findings, identify current resources and training opportunities for
 infants/toddlers/children identified as deaf or hard of hearing in cognitive,
 social, and emotional developmental process and developmental
 milestones. The first meeting was held June 20, 2017.
- An Advisory Board comprised of diverse individuals who are deaf and hard of hearing has been assembled to provide input to, review the results and make recommendations from the national needs assessment of families. This will help support an increase of mentor opportunities and involvement of trained D/HH individuals in EHDI systems, and raise parent awareness and value around the critical role of DHH adults. This advisory board met on June 21, 2017
- The FL3 program is available to support state/territory EHDI systems and the
 identified Family Based Organizations to improve family engagement,
 partnership, and leadership within the EHDI System. Examples of recent
 technical assistance that has been provided includes; assisting with work
 plans, budgets, parent to parent support programming, DHH Adult to parent
 support programming, etc.


