# Deaf/HH Plus: A New Group for Families with Deaf and Hard of Hearing Children with Additional Challenges

We have many families with Deaf and Hard of Hearing children who have additional health challenges and for quite some time, parents have expressed interest in connecting with one another. Hands & Voices now has a new Facebook group: Deaf/HH Plus.

Deaf/HH Plus is meant to be a positive term, not in any way negative or insensitive to the child who has medical issues along with hearing loss. In fact, we see it as an "A+" or "B+," meaning the child carries additional positive qualities and it is a gift that needs to be carefully unwrapped. And the "Plus" most often means the child and family has added responsibilities and requires additional expertise."

We are grateful for the love and support of professionals and other parents whose children do not have a "Plus." This new group is meant to be a safe place for families with DHH Plus children/adults and we ask our allies to invite only families who share this same experience.

The group is moderated by Danielle Sibert, Djenne-ammal Morris and Candace Lindow-Davies. Participants will need to answer two questions about whether they are the parent of a child or parent of an adult who is DHH and whether their child/adult child has other health considerations. # **EHDI Legislation Update**



On October 19, 2017, U.S. President Donald Trump signed the Early Hearing Detection and Intervention (EHDI) Act of 2017 into law, which will fund continued research and improve program development for early hearing detection and intervention in newborns and young children who

are deaf/hard of hearing for the next five years. Young children are now included as part of early hearing detection and intervention programs.

EHDI has allowed newborns to be screened for hearing loss before they leave the hospital, paving the way for early identification and intervention. Statewide programs require initial hearing tests in infants, evaluations to identify hearing loss, and the services and early intervention programs that put children on the path to develop critical skills necessary to succeed.
