* The formal, national needs assessment that is being coordinated with the National Center for Hearing Assessment and Management (NCHAM) to gather information on family engagement within the EHDI systems is in full swing. Surveys have been sent out to various individuals and focus groups have been convened to gain knowledge about their experiences within the EHDI system. This information will be used to drive the content of the trainings, educational materials and resources that will be developed and distributed over the remaining period of the agreement.

* The FL3 program is available to support state/territory EHDI systems and the identified Family Based Organizations to improve family engagement, partnership, and leadership within the EHDI System. Examples of recent technical assistance that has been provided includes; assisting with work plans, budgets, parent-to-parent support programming, DHH Adult to parent support programming, etc.
